- IX. What Have We Done Well?

We utilize intergovernmental agreements with neighboring townships to reduce costs to tax payers.

We have switched over to electronic accounting and file organization/storage.

- X. What Inefficiencies Did We Identify/What Are our Next Steps?

 We have found that when the necessary tools to perform service/maintenance/repairs on township equipment/buildings, that the commissioner would drive several miles round trip to borrow personal tools from his farm or take the township equipment to his farm for repairs. We plan to purchase necessary tools and equipment to keep at the township maintenance building.
- XI. What Can We Do Better or More Efficiently? Inhouse service and maintenance.
- XII. Studies on Governmental Efficiencies

In preparing this report, we reviewed several studies on local government efficiency. These studies show that:

- The average local government in Illinois serves 1800 residents compared to the national median of 2850 individuals
- Most townships in Illinois have no bonded indebtedness. Together with road districts they are an integral element of local democracy. Township expenditures have grown at a lower rate than those of any other level of government since 1992.

- Townships have lower labor costs and employ mostly part time employees.
 - XIII. <u>Our committee's recommendations regarding Increased Accountability and Efficiency:</u>

We recommend that Barr Township purchase the necessary tools/equipment to allow continued increase with inhouse service and maintenance on buildings and equipment, not to exceed the capabilities/knowledge of the Highway Commissioner or part time employee.
