The following is a list of things we feel we have done well.

- 1. Reduced tax levy rate (in 1989 the tax levy rate was .6630 well in 2023 it is .34794 And the per cent of township taxes in 1989was 9.7% and 5.67% in 2023
- 2. In the past 10 years we have spent less each year than what was budgeted
- 3. We have in the past 15 years upgraded the equipment, built a new storage shed for the equipment, new siding on old shed in 2023, added landscaping around the property, a new sewer system facility for the Township and a new roof for the main building.
- 4. We have participated in the following projects with the city
- 5. Helped fund a new culvert for the bridge crossing to the Old City Cemetery
- 6. Had a tire collection to get rid of old tires in the Township in co-ordination with The county resulting in getting rid of over 5,000 tires in the Township

- 7. Improved with the city the ball fields by adding additional parking space and electronic score boards
- 8. Improved with the city additional parking and new sidewalks on the soccer fields
- 9. Funded a portable bath and shower facility to the park for the Tour De Donut race held each year which brings in over 1,000 bike riders to the community
- 10. Aided the Helping Hands Food Pantry financially to get started which serves over 300 families each month.
- 11. Have help fund Eagle Scout Projects that benefit the community, the Staunton Lions Christmas Program that aids families in need, the Staunton Hospital (purchase of new AED units), and the VFW for new Heating and Cooling Systems since it serves as a community center in extreme cold and heat,
- 12. Installed computerized accounting system (Quick Books)
- 13. Partered with the city and VFW in purchasing new van to take Veterans to Veterans' hospitals in St. Louis
- 14. Added Solar Panels to Reduce Power Cost

- 15. Assisted Dorchester Township with Funding for replacement of old bridge As Staunton Township Residents also use the bridge
- 16. Support the Patriot Club at the high school for outstanding Patriotic program They perform every year
- 17. Assistance City in Replacement of Roof on Soccer Storage Building

The two committee members of the community did a complete inspection of How monthly and annual reports were completed and presented to the trustees, did financial analysis of accounting procedures and how records are kept and concluded the Township operates a highly efficient office with complete transparency. Also was impressed Township had an array of modern equipment and equipment was stored Properly with two updated buildings.

• The average local government in Illinois serves 1800 residents compared to the national median of 2850 individuals

- Most townships in Illinois have no bonded indebtedness. Together with road districts they are an integral element of local democracy. Township expenditures have grown at a lower rate than those of any other level of government since 1992.
- Townships have lower labor costs and employ mostly part time employees.


